



GGAR Awards Program

We encourage you to participate in the Greater Gateway Association of REALTORS® Awards Program. The Awards will consist of a complimentary Certificate of Achievement and the option to purchase an Awards Plaque for \$20 or complimentary name plate if you currently have a Perpetual Plaque that you are trying to complete. The Special Awards this year will consist of honoring the Affiliate of the Year, REALTOR® of the Year, Rookie of the Year and The Good Neighbor Award. Come out and celebrate the inaugural presentation of the distinctive awards Hall of Fame and REALTOR® Advocate. The awards will be presented at the Awards Banquet, which will be held on **Saturday, March 18, 2017** at The Commons, Lewis and Clark College in Godfrey.

- **The completed awards packet must be received at the Association office no later than close of business on **January 31, 2017** to be included in the Awards Program.**
- Awards can be submitted as individual or team.

Eligibility:

Any current REALTOR® member in good standing of the Greater Gateway Association of REALTORS®.

Production Guidelines:

When a REALTOR® lists a property and another REALTOR® sells that property on a cooperative basis, both applicants may claim total gross sales for the award credit. The transaction counts as one unit for each applicant. When an applicant lists and sells a property, the applicant may claim the total gross twice—once as a listing and once as a sale. This also counts as two units toward the award credit.

When two REALTORS® working as individuals co-list or two REALTORS® working as individuals co-sell a property on a cooperative basis, each may claim only one-half of the gross of the sale and one-half of a unit for the award.

GGAR recognizes REALTOR® members who participate in the required sales transactions with units closed or dollar volume closed during the calendar year of application for the award. Rentals and referrals are not recognized for credit toward the award program. Eligible real estate sales include transfer of title on residential, commercial, land, industrial, and/or agricultural sales only.

Verification:

Verification of eligibility for membership must be confirmed by each applicant when applying for the award and must be certified by the current managing broker with whom the applicant is associated. GGAR reserves the right to audit applications as deemed necessary.
